

RULES FOR ENTERING THE PRIME MINISTER'S NATIONAL ENVIRONMENTAL COMPETITION

1. Each Village/Community Council, Youth Group, Women's Group, Sporting or Cultural Group must be a properly constituted organisation with an elected structure.
2. Before entering the competition the Organisation must possess a banking account with a recognised commercial bank, with evidence of at least 3 authorizing signatories.
3. All documents must be submitted to the Best Village Head Office, Ministry of Community Development, Culture and Gender Affairs through the District Offices.
